

Text Quality Evaluation Results

This document presents the results of the evaluation of a data-to-text system for generating narratives from Activity of Daily Living (ADL) data, as described in:

Pierre-Luc Vaudry and Guy Lapalme. September 2016. Assembling Narratives with Associative Threads. *CC-NLG 2016 - Proceedings of the First Computational Creativity in Natural Language Generation Workshop*, Edinburgh, United Kingdom, September. Association for Computational Linguistics.

This page gives a summary of the results. The rest of this document gives detailed results for each evaluated generated text, one text per page.

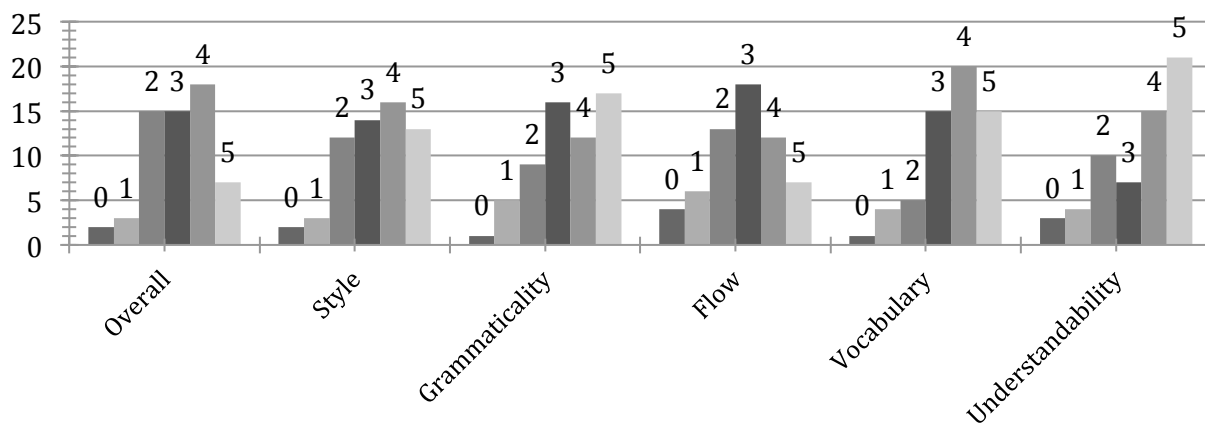


Figure 1. Number of evaluations for each rating value for each criterion.
